Presidents report

2020 has been hard on trail use clubs as there have been a lack of event fundraising and maintenance events. Though 2020 was tough, trail use has been rediscovered by the public. Some of the advantageous actions by the STA board include:

The name rebranding represents trail users alike, not only mountian bikers, which we have already seen an increase. 87 members in 2020, expected increase in membership for 2021.

All board members have been trained through IMBA for trail sustainability, design and maintenance.

Currently working through agreements with the MVA and City of Saskatoon to submit maintenance plans.

Our board has successfully submitted and actualized maintenance days in September of 2020; 6 Kilometers maintained and 30 volunteers, and will continue to do so in 2021 with the continued support of MVA and City of Saskatoon

Treasury report

The STA finished the fiscal year in a positive position. Revenue memberships are up. The Kinsmen club grant as well as the Tool grant has proven prosperous to set us up for a positive 2021.

The STA will put expense into bringing In IMBA again for training and continuing to educate in 2021 as we did in 2020.

There will be a new accounting program the STA is looking into which will be cloud based. All board members wil eb able to view the financials. This new system will make the treasury position transferrable to any future member of the STA Treasury.

Generalized agreement with MVA, The STA would like blanket permission to maintain at will and when situations arise. The STA is currently working with MVA and City of Saskatoon towards this agreement.

Sustainability of trails a part of our agreement? Discussions have been had but not yet presented. The STA would like to have a similar agreement to that of Edmonton Alberta's sustainability agreement.

Concerns regarding spring runoff and winter thaw? Some members of the STA would like to see larger permanent signs regarding the caution and detriment of use on trails while spring runoff. The STA will take this under advisement at this time

Tool Purchase

Pending grant approvals to purchase tools, The STA would like to purchase club tools for general maintenance. Pending purchases are "Out of Stock", local suppliers may acquire stock "short term"
